

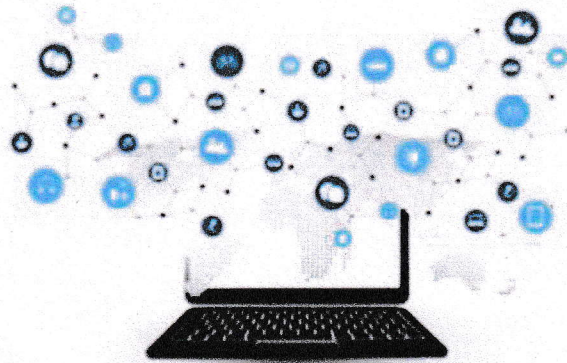

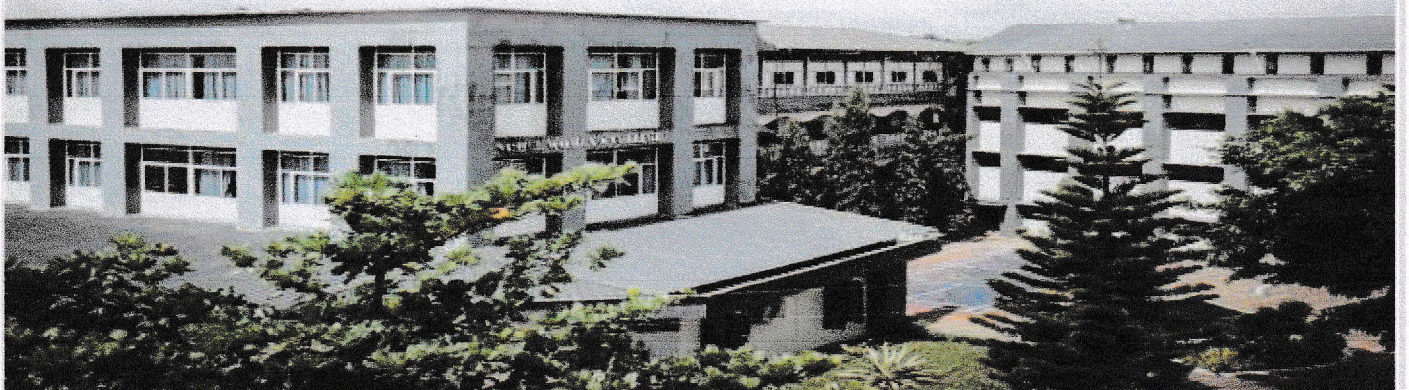

ICT POLICY

This policy outlines the guidelines and principles governing the use of Information and Communication Technology (ICT) resources within College. Acceptable Use

- ◆ Prioritization: Priority for IT resources will be given to academic and administrative functions over personal or non-academic activities.

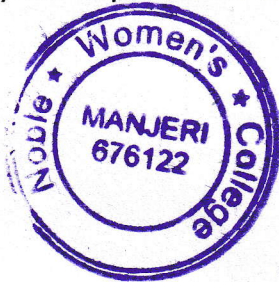
Compliance and Enforcement
